重要啟示 Important Notes To Client

- 如股票登記持有人為中央結算有限公司，客戶須提供提貨收據或其他文件，證明其擁有權。此外，客戶亦可先將股票轉入其名下，才將股票存入本公司。否則，本公司將不接受該股票存入。If the registered holder of the stock is in the name of CCASS, client is required to provide the Company with the withdrawal receipt or other documents evidencing his/her ownership of the stock.
